Chair Report

Library Area of Impact

Mr. Helweg turned the meeting over to Rob Harrington and Jenni Gaisbauer to update the Board on the CommonSpark campaign.

Ms. Gaisbauer reported the following:

Redefining "Library"

- Hub of Collaboration. Half of programs will be presented by or with community partners, and relationships establish the Library as a clearinghouse for trusted community information.
- Technology-forward. Well-integrated digital tools including a data visualization lab, multimedia studio and immersive theaters increase access and bring information to life. Powered by a flexible infrastructure designed for the technology of today and tomorrow.
- Destination for residents and visitors. A destination and anchor for uptown's developing knowledge corridor.
- Center for Connection. The Library connects people with information, opportunity and one another. Embedded social workers will support our most fragile neighbors

- Welcome newcomers and connect them with community resources
- Capture, preserve and share the stories of our community

Committee Reports

Finance Committee

Angie Myers provided the following updates:

Financial Analysis

- Projection data is based on 9 months (75% of the year) of activity. The Library has reduced internal revenue generation projections for all of FU 2021 due to the continued impact of COVIED-19.
- The County Manager is expected to announce her recommended FY 2022 budget on Thursday May 6th.

Budget Adjustments

• \$217,750 from Revenue: Other to Expenditure: Professional Services for 7th & Tryon Predevelopment Expenses – Partner (City & Bank of America) Funding

Budget Transfers

- Approval granted from Mecklenburg County Manager, Dena Diorio on 3/16/21 for items below that were presented during the March 15, 2021 Board of Trustees Meeting.
 - o \$700,000 from Salaries & Benefits to:
 - \$206,847 to Professional Services for the Library's portion of 7th & Tryon Predevelopment Expenses
 - \$221,441 to Professional Services for County's portion of 7th & Tryon Predevelopment Expenses
 - \$157,712 to Misc. General Operation for Marketing & Advertising
 - \$100,000 to Facilities Related for Maintenance
 - \$14,000 to Professional Services for CEO Recruiting/Relocation

On a motion by the Finance Committee, the Board of Trustees unanimously approved the Budget Adjustments and Transfers.

Governance Committee

Rob Harrington provided the following updates:

- As a reminder, there were 4 Trustees scheduled to roll-off this year and given the number of important initiatives taking place in the organization, we made a request to the BOCC to allow Gloria Kelley and myself to serve another year on the Board and the BOCC approved our request last month.
- The deadline for applications for the Board of Trustees is April 28, 2021 and the Governance Committee is recommending John Buchan and Tracy Montross to fill the 2 vacant spots.
- Tracy Montross has served as Regional Director of Governmental Affairs for American Airlines since 2014. In that role, she represents American Airlines with public bodies from Washington, D.C. to Tennessee. Ms. Montross has a distinguished career in public service in Charlotte.
- Jon Buchan has practiced law in Charlotte for over 40 years. He is a partner with Essex Richards, P.A. He is one of the state's leading media and First Amendment lawyers and scholars.
- In addition to the recommended new appointments to the Board, both Charles Thomas and Brandon Neal are up for reappointment at the end of June. Our recommendation to the BOCC will also include their reappointment.

Real Estate Committee

Brandon Neal and David Dillard provided the following updates:

- University City Regional:
 - O Charlotte Mecklenburg Library is engaging in a Public Private Partnership (P3) pursuant to NC General Statute (GS) 143-128.1C to develop a new 40,000 sf University City Regional Branch library. The process will be initiated with a statutorily required public advertisement of a Request for Qualification (RFQ) for responses by interested development teams.

• Pineville:

- o Rain has delayed construction slightly, but will not impact Library's occupancy date
- o Footings are in place
- o Exterior wall mock-up is in place
- AFM is fully engaged as the Project Manager representing the Library's interest.

Main Library:

- AFM is close to final execution of the architectural services contract for design development and construction drawings.
- o AFM will lead a Budget Alignment process with all stakeholders once the contract is executed.

Support Services Center:

- Construction is proceeding according to schedule.
- o David Dillard has led several tours for Library departments that will move to SSC when it opens.
- Rodgers Builders is working to mitigate the delivery time required for a couple of long lead items that will likely extend the substantial completion date.
- Action Item: RFQ and Contract for Special Inspections & Materials Testing

Action: Authorize Mecklenburg County Asset and Facility Management, on behalf of the Library, to create and advertise a Request for Qualifications (RFQ), evaluate responses, and make selections of firms as part of a Special Inspections and Materials Testing scope of work needed for multiple locations, which includes Main Library and Spirit Square. Also, authorize Library CEO Marcellus Turner to execute the contract that AFM negotiates on the Library's behalf for these services for the Main Library/Spirit Square project.

- Children gain skills needed to start kindergarten
- Research shows that reading 20 minutes a day during the summer helps prevent summer learning loss

Why Summer Learning?

- People learn in different ways and many different activities can be educational for all ages.
- Our challenges offer flexibility in how customers participate.
- Learning how to set and meet goals is one of the many ways summer learning helps teens develop into healthy, productive adults.
- Adult brains benefit from regular learning activities, like reading.
- Community engagement with Library partners.

Reading Time

- Users can enter any time they spend reading during the summer.
- Everything counts books, magazines, audiobooks, etc.
- Users can track their reading time going back to the start of each challenge.
- You can log 10 times per day, and up to 10 hours of reading at a time.
- Designed for 30 minutes a day of reading
- Read at least 15 hours to finish.
- Everyone is welcome to exceed 15 hours.

Activities

- There are several activities in each category/track
- Participants must complete at least five (5) activities:
 - Must be one activity in each category/track
 - Write, Create, Play, Explore, Give
 - There will be activities for all ages/family activities under each badge
- Participants must complete at least one (1) activity in each track to earn the activity badge.

Completing

To complete the Summer Break challenge:

- Log at least 15 hours of Reading and
- Log at least 5 Activities and one from activity in each category (Write, Create, Play, Explore, Give)

Throughout the year the Library saw steady increases in programs offered, with the exception of the holiday months. A large jump in both number of programs and total attendance can be seen in September, which is the same time we launched BiblioEvents, our new online calendar software. There has been a steady increase in all areas since January 2021.

During FY19 the Library offered 247 unique programs, delivered 29,691 times, reaching 455,279 attendees in-person.

Stories of Impact

- I was worried before my daughter started kindergarten because she was too shy, and wasn't confident to answer others' questions. That was the reason I signed her up for Reading Buddies, a couple of months before her kindergarten. It really helped! Now she is a kindergartner and attending virtual class. She's not shy when she has to say something. And she enjoys reading, as well. Thank you for all who work for the great program! Reading Buddies
- A customer hoping to make a total career pivot from gym ownership to day trading has been booking 1-on-1 career appointments with Tonya Lewis at Sugar Creek. After the latest sessions, the customer was extremely excited about the guidance provided and said he felt even more comfortable about making this career shift because of the many ways Tonya shared for him to get connected. 1-on-1 Career Support Session
- A participant in IB's adult poetry club shared: "I haven't felt happy or laughed in months, this is the first time I have been able to do this, I had a really good time, thank you!" He said this with a smile after stating he has

been feeling very low due to the pandemic. He plans to continue attending the virtual meetings monthly. *Poetry Club @ IB*
