- **Basic Search** Enables you to find a company using the company name or ticker symbol. Lists of companies can be searched by Primary SIC, Primary NAICS, or MIC codes. You can also include private companies in the basic search and restrict the search to US or International exchanges only.
- Advanced Search Allows you to specify a wide range of textual and financial criteria to be searched for. These criteria are textual or numeric information within the data stored on companies. Multiple criteria can be set, combined with AND or OR, for even greater refinement in searches. You can choose from 8 different categories of information which to build criteria for your specific search: Corporate Information, Executives, Financials, Industry Codes, Pricing, Ratios, Textual Search, and Portfolio & Index.
- **Executive Search** Allows you to specify a wide range of textual and financial criteria to be searched for. These criteria are textual or numeric information within the data stored on companies' executives. Multiple criteria can be set, combined with AND or OR, for even greater refinement in searches. Choose from 8 different categories of information from which to build

criteria for your specific search: Corporate Information, Executives, Financials, Industry Codes, Pricing, Rations, Textual Search, Portfolio & Index.

- **Government Filings Search E**nables you to search the EDGAR government filings either by company information or by date or both.
- **Bond Viewer** Has both a Basic Search and an Advanced Search. Search by identifiers (Issuer name, Issue name, Ticker, Mergent ID, CUSIP, ISIN or Industry Code. Date ranges searchable by the Offering Date Range, Maturity Date Range, and Next Call Date Range.
- **Country Insight Report Search** Allows you to search the Mergent Online database for Mergent's Equity Portraits and Industry Reports.
- **Economic Research** Leading search indicators from around the world.
- Industry Analysis Allows you to interactively explore Industry characteristics data through charts and tables as well as access PDF reports based on ICB classifications. The data shown is generated using data from members of the Russell 1000 assigned to the given ICB industry groups. Check out the Industry Analysis Quick Reference Guide for more help.
- **Report Viewer C**overs Company Reports, Annual Reports, Mergent Reports and Company Portraits. You can download the Summary Report, Fundamental Report, and the Expanded Fundamental Report of any asset.
